10	Original Degree / Provisional certificate, if qualifying degree is completed. In these cases, all exams should have been completed by August 15, 2026. A certificate from the head of the current institute (format given on the CCMT website) to that effect should be submitted during reporting.

- If the original certificates are not in Hindi/ English, duly certified Hindi/ English version/ translation of such certificates have to be mandatory brought, failing which the certificate may not allowed.
- Candidates are instructed to keep sufficient number of Photocopies of the original documents submitted.
