The admission procedure for the candidates who had provisionally allotted a seat in B. Tech./B. Arch. Programmes of National Institute of Technology Raipur for the academic year 2026-2027 through DASA-2026 counselling processes given below shall be as shown from the next paragraph:

1. The candidates who have participated in DASA-2026 and successfully verified their documents online at organizing institute IEST Shibpur and paid all the required fee as mentioned in DASA –2026 procedure.
2. The candidates who have allotted the seat in DASA-2026 (All rounds) of allotment and finalized their seats in NIT Raipur.

Procedure for Reporting in Person at NIT Raipur

1. The candidates who have been finally allotted NIT Raipur need **to access the institute MIS/login through ONLINE mode before physically reporting as per the scheduled mentioned in Table-1 to NIT Raipur** for admission. The link for the same is given below (the link will also been sent to your registered email id as per JoSAA/CSAB records), **which will be activated 1-2 days prior to the physical reporting date** (subject to the allotment of DASA):

The candidates need to login in the institute interface (MIS) for provisional admission through their

JEE(Main) Application Number, Date of Birth, and other credentials. Please fill all the editable fields as provided at your login, with correct information and upload your photo and signature. An email will be sent to your registered email id on successful completion of above entry on the MIS.

You need to show this email at the counter (Help Desk and Registration Counter) at the time of Physical reporting to the institute. In case of any difficulty in MIS related issues, the candidate can write email to ugadmission@nitrr.ac.in.

Kindly note that merely entering the details after logging-in shall not make you eligible to take admission at NITRR unless you have not been allotted NITRR by DASA - 2026. During verification by officials if it is observed that you have not done the formalities as per the instructions, your entered data will be removed from the institute database, and you will be treated as unadmitted/cancelled candidate.

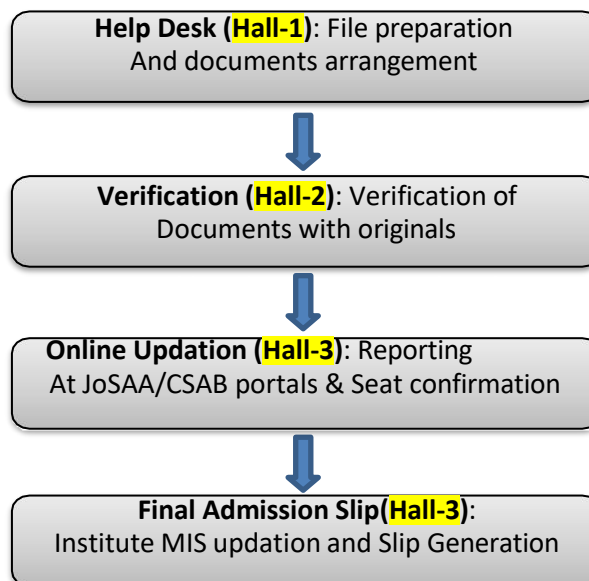
