- 6.1 are properly signed ; and
- 6.2 Confirm to the terms and conditions, and specifications.
- 6.3 The Tenderer / Bidder need to submit the following certificates along with the quotation to Confirm their eligibility:
- * Proof of establishment of Firms/shop/business/manufacturing unit etc. and Dealership certificate from the principals etc.
 - * A valid Sales Tax/Commercial Tax/Service Tax certificate should be enclosed.
 - * Photocopy of PAN card issued in favor of the bidder
7. The Quotations would be evaluated for all items together.
8. Award of contract:
The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
